- Brian gave his Executive Director's Report. He said Market Street has been car-free for a month. The
  Coalition is conducting their own feedback effort. Valencia St is part of the City's new quick-build policy,
  but it may go to the full SFMTA Board for approval.
- Port Commissioners unanimously voted to go to SFMTA and come back with a plan for two-way protected bikeway for the entirety of Embarcadero.
- April 4th is the 150th anniversary of Golden Gate Park the entire park will be car free for a day.
- Freeway access will be banned on Page Street.
- In early March, the protected bike lane will be completed on Townsend St.
- There is a meeting this Saturday at 10am on Fulton St. If you ride in Richmond, SFMTA will be holding a public meeting.

- April 18th is our Family Bike Fest fundraiser. Please join us!
