Jean Kao called to order the Annual San Francisco Bicycle Coalition Education Fund Board Meeting with a quorum present.

## **Annual SFBC Education Fund Board Meeting** - Board

- Intros; Update on the SFBC Education Fund operations & financial performance.

Brian Wiedenmeier provided clarification on the roles of a 501(c)4 corporation versus a 501(c)3 corporation and historical context as to when and why the San Francisco Bicycle Coalition Education Fund 501(c)3 was established.

Brian also provided an update on the financial performance of the San Francisco Bicycle Coalition Education Fund highlighting the following:

- The primary revenue sources are membership dues and some contracts
- The corporation is in a healthy financial position with a 3-month operating reserve, 6-months if and when the federal PPP loan is forgiven

Roan Kattouw noted a typo in the minutes. With the correction the minutes were approved unanimously.

#### 3. Finance

- o Purpose: Information, Close
- Update on our financial performance.

Raul Young reviewed the April 2021 financials, highlighting the following:

- Net income was higher than budgeted due primarily to a few generous individual contributions and the unanticipated disbursement of a grant
- Valet bike parking program is operational again and it shows in the program fees
- Overall the organization maintains a healthy cash balance
- We continue to be assured that the delayed timeline for PPP loan forgiveness is not abnormal; an application for forgiveness of the second PPP loan will be submitted in the coming week

#### 4. ED Report

- o Purpose: Information
- o Update on the Strategic Plan and work of the organization.

Brian Wiedenmeier recognized Rahul's last meeting and expressed appreciation for his partnership, commitment, and spirt of joy over his three years with the organization. Rahul expressed gratitude for his time at the organization.

Brian provided an update on the Strategic Plan and other work of the organization, noting that the updated Strategic Plan dashboard will be shared with both interim and permanent executive directors as foundation for the next strategic plan. Highlights included the following:

- Approximately 30 miles of new bike lanes implemented since 2018
- BTWD- It happened, it happened in person, looking forward to more meeting people where they are in the streets and growing our organization
- New commitments from Mayor Breed, including more miles of protected bikeways, bike parking and secure bike parking, more quick build projects
- Slow Streets program to become permanent (street by street basis, maybe not the whole network)

Susan Mooney provided information and advice regarding leadership transition, how the roles of interim and permanent executive directors differ, and what qualities to look for in an interim executive director.
