4a (Code:) (Expenses \$ 578,743 including grants of \$) (Revenue \$ 595,703) Core Program - In 2014, the San Francisco Bicycle Coalition focused on its core goal of increasing the number of people bicycling. A key part of this effort is to expand and improve the city's bicycling network. This year we advanced our vision for a complete, cross-town bike network system that is safe and welcoming for people ages eight to 80. We worked closely with volunteers, members and community groups to get the government to translate this vision into on-the-ground projects and funding for projects to be constructed. In 2014, on the ground improvements included protected bike lanes on San Jose Avenue connecting the Mission, Excelsior and Glen Park to the award winning blocks of lower Polk. Other bicycling infrastructure improvements to help more people, including families and kids, on Cesar Chavez, Folsom Street, and Ortega Street.

4b (Code:) (Expenses \$ 42,607 including grants of \$) (Revenue \$) Advocacy - In 2014, the San Francisco Bicycle Coalition worked on getting the government to increase the amount of secure bike parking on the street and in buildings, and to improve access to regional transit. We reached out to businesses and other entities throughout the city to encourage them to apply for bike racks and corrals in front of their buildings. We also worked with regional stakeholders and government to help a local transit agency test allowing bikes on trains at all times.

4c (Code:) (Expenses \$ 88,764 including grants of \$) (Revenue \$) Elections - The SFBC also continued educated, endorsed and helped campaign on behalf of bicycling-friendly elected officials and ballot measures on the Fall 2014 ballot. The election featured a race for 4 of the Supervisorial seat and 3 propositions; Prop A, Prop B and Prop L. SFBC worked with our members and Board to interview and select candidates for endorsement, and then organized volunteers and members to educate bicycling voters about our endorsements. We also sought to educate all candidates about how to work on behalf of great bicycling in San Francisco.

position to influence a purchase, contract or lease, it is imperative that he or she disclose

the conflict of interest to an SFBC officer, and safeguards will be established. An employee

will not offer business services similar to services offered by SFBC nor will he or she use

SFBC's name for personal benefit outside of the scope of employment duties. If management has

reason to believe that a violation of this policy has occurred, management will afford the

staff or board member to an opportunity to explain the alleged failure to disclose. If

necessary, management will take appropriate disciplinary and corrective action.
