Terms and Conditions of September 2017 Member Drive (Republic Bike Raffle)

The September 2017 Republic Bike Raffle is a one-time promotional event, supporting the SF Bicycle Coalition's September Member Drive

1. All memberships of \$35+ will receive one entry in the raffle. Memberships of \$50+ will receive 2 entries and Monthly Giving memberships will receive 3 entries. Current members who give a gift membership will receive one entry. Entries will be given to the primary person on the membership.
2. Due to privacy and security reasons, submitted email addresses will not be confirmed or denied as currently being associated with the San Francisco Bicycle Coalition 2017 September Republic Bike Raffle.
3. Raffle entry will only be credited to all new and renewing members during the month of September based on the amount of their contribution.
4. This offer is only open to current, new and renewing San Francisco Bicycle Coalition members.
5. Enrollment as part of the 2017 September Republic Bike Raffle Promotion can not be made on behalf of new or renewing members to another individual.
6. The San Francisco Bicycle Coalition reserves the right to change or cancel this offer (or any portion thereof) including the award levels at any time.
7. The San Francisco Bicycle Coalition reserves the right to change, suspend or discontinue any aspect of the 2017 Republic Bike Raffle, including the availability of any features, information, database or content, or restrict your access to parts or all of the offer pages without notice or liability.
8. The San Francisco Bicycle Coalition will not be responsible for emails related in any way to this offer that are undeliverable or cannot be opened by the recipient.
9. The San Francisco Bicycle Coalition will not be responsible for any awards that fail to be credited due to inaccurate, corrupted, or incomplete information related to membership in the San Francisco Bicycle Coalition and subsequent accounts.

1. The winning San Francisco Bicycle Coalition member of the bike, hereafter referred to as "Winner" and "the Prize"; respectively, must be a current San Francisco Bicycle Coalition member.

Raffle Entries will be awarded by SF Bicycle Coalition Staff at the following rates: Members who purchase a new or renewing membership at the rate of \$25 or more will receive one raffle entry; Members who purchase a new or renewing membership of \$50 or more will receive two entries. Members who enroll in the Monthly Giving program will receive three entries. Members who purchase gift memberships will receive one entry for themselves.

3. The Winner will be chosen at random from the entries received in the September 2017 Republic Bike Raffle Promotion.
4. The San Francisco Bicycle Coalition will automatically disqualify: 1) Any submission from a non-eligible individual; 2) an incomplete or illegible entry; and 3) any entries received in violation of the terms and conditions described here within.
5. The Winner is fully responsible for any and all costs and expenses associated with Prize acceptance and use not specified herein as being provided. Each Winner agrees to comply with all applicable laws and regulations in connection with the Prize.
6. The Prize is one Republic bicycle provided by Dave Howes and the Climate Ride, and is non-transferable, with no cash redemptions. The San Francisco Bicycle Coalition reserves the right to substitute a prize (or portion thereof) with one of comparable or greater value at its sole and absolute discretion.

If the San Francisco Bicycle Coalition does not hear from the potential Winner within seven (7) days of date of issuance, a disqualification will result, and the Prize will be forfeited, at the San Francisco Bicycle Coalition's sole discretion.

Time permitting, an alternate potential Winner may be chosen from among all remaining eligible entries.

Failure to submit any identification required by the San Francisco Bicycle Coalition or to return the required documents within the time period specified by the San Francisco Bicycle Coalition, noncompliance with these Official Rules or the return of any Prize or Prize Notification as undeliverable may result in disqualification, and Prize will be forfeited and, at the San Francisco Bicycle Coalition 's sole discretion and time permitting, may cause an alternate potential Winner to be chosen from among all remaining eligible entries.
