#### Internal Culture:

- Digital community agreements have been drafted, vetted by staff, and posted on our website and social media.
- A sabbatical policy is currently being drafted. The hope is to share the policy with the board for approval in January, and make it effective in FY22.

#### Advocacy:

- The anti car-free JFK contingent have launched their opposition. We have drafted a blog response.
- AB-43 was signed. This bill updates the way speed limits are set, which will give more flexibility for slower speed limits.
