#### 4. Committee Updates

- o Purpose: Information
- Update from board committees (including board development, hiring and strategy committees)
- Board Development and Governance (Jean)
  - Set a timeline for the next board election. Same as last year, shifted by a day or two
  - Jean attempted to recruit one candidate who doesn't have time for the c4 board. Besides that, no candidates recruited yet.
  - Board members whose term is up this year should make sure Jean knows whether they intend to run for reelection
  - If you know any potential candidates, please introduce them to Jean so she can talk to them about what board service involves. Chris is also available to talk to any interested candidates who want to.
- Strategy retreat (Brandon)
  - We'll meet on Dec 8 at Ryan's office
  - Agenda will be circulated by Dec 1, there will be homework to do beforehand
  - Staff will have a staff development day the day before, on Dec 7
- Search (Raynell)
  - Had a conversation with a nonprofit recruiter. See Slack for notes.
  - Otherwise, holding off until after the retreat

#### 5. ED Report (20m)

- Purpose: Information
- Update on the Strategic Plan and work of the organization

- o Chris gives update:
  - Winterfest revenue was below goals, but net income was still \$47k
  - ACP: Ending outreach contract, now shifting focus to advocacy. A good plan won't implement itself, we'll have to keep pushing on it
  - Valencia: Hearing quiet support for the bike lane from some people. Advocacy team listening to local community to understand all points of view about the bike lane pilot. Also approaching merchants.
  - Oak: Starting a campaign soon for a protected bike lane on Oak along the Panhandle
  - Bike Ed: Applying for a new contract, 3x the size of the old one, also includes scooter education
  - Bike It Forward: Thanksgiving event on Nov 21 on the Golden Gate Greenway by St Anthony's. Gave away 25 bikes. Successful event, planning another one in the spring
- 6. Finance (15 m)
  - o Purpose: Information
  - Update on prior month finances.
  - Chris presents financials
    - Overall, trending pretty close to the budget. Shortfalls in some categories canceled out by windfalls in others.
    - October financials contain both the Sept and Oct Safe Routes To School income and payments, which is why Contracts and Professional Services are much higher
    - Chris asks all board members to help with Year End Appeal
